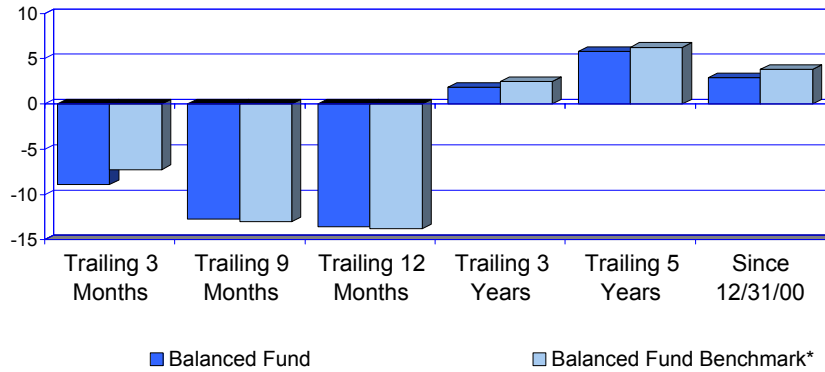

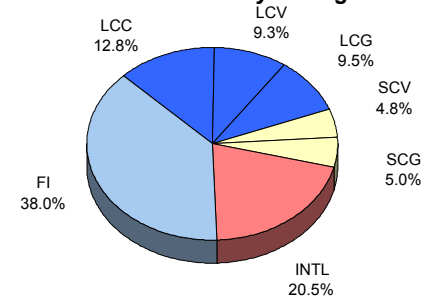

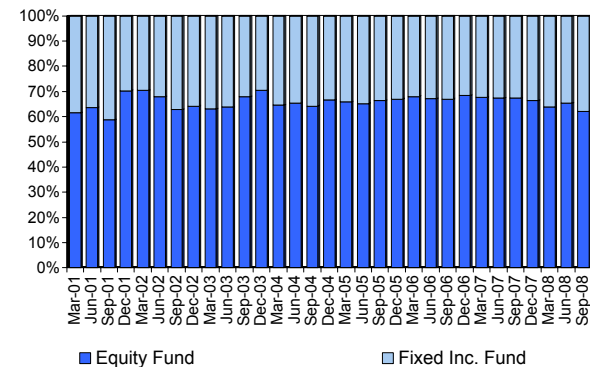

Allocation Over Time

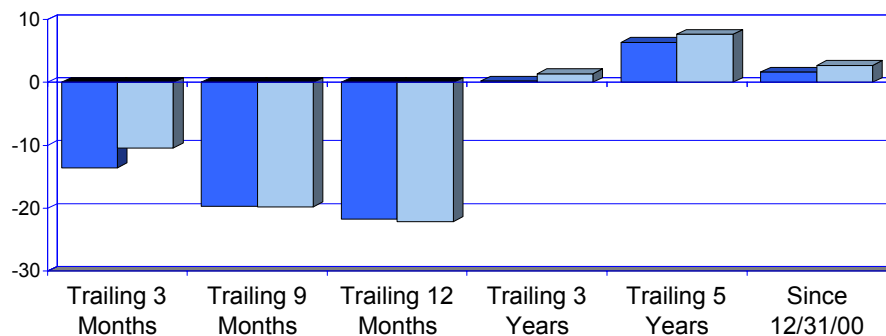

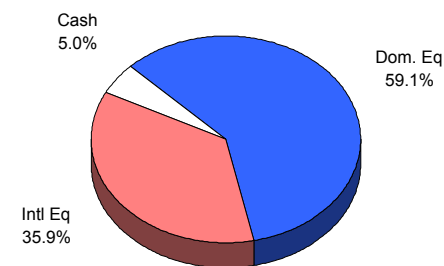

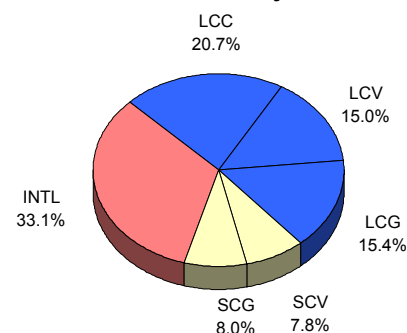

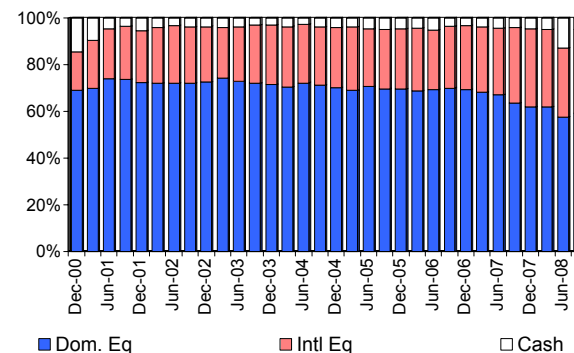

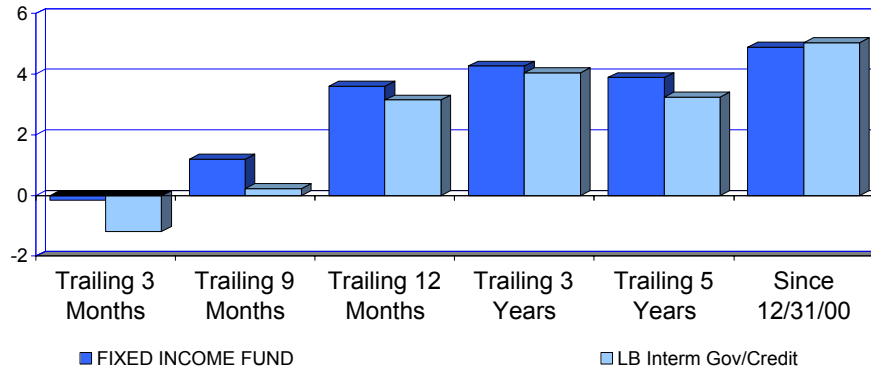

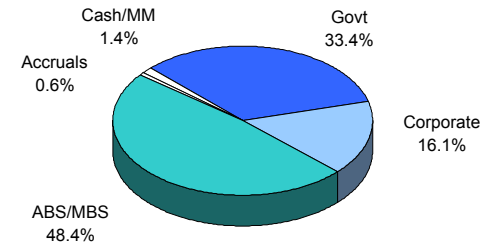

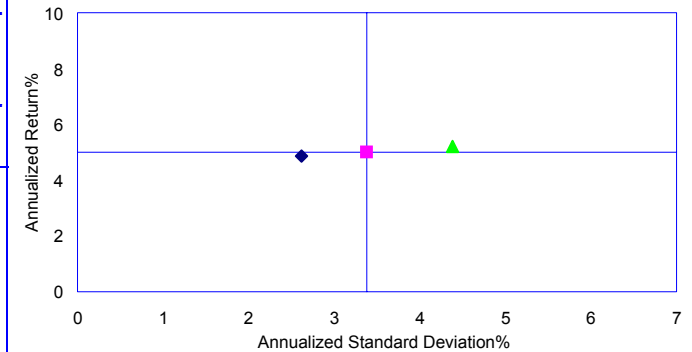

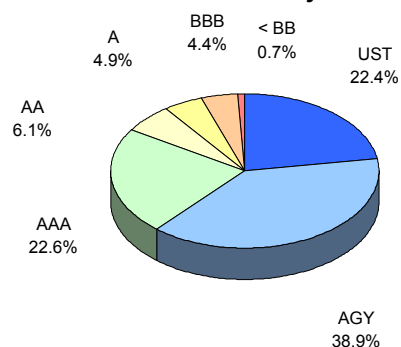
Risk / Return Analysis Since 12/31/2000



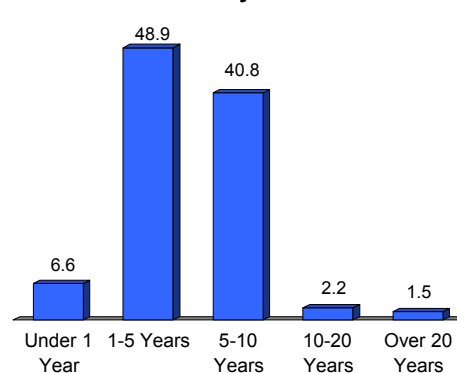

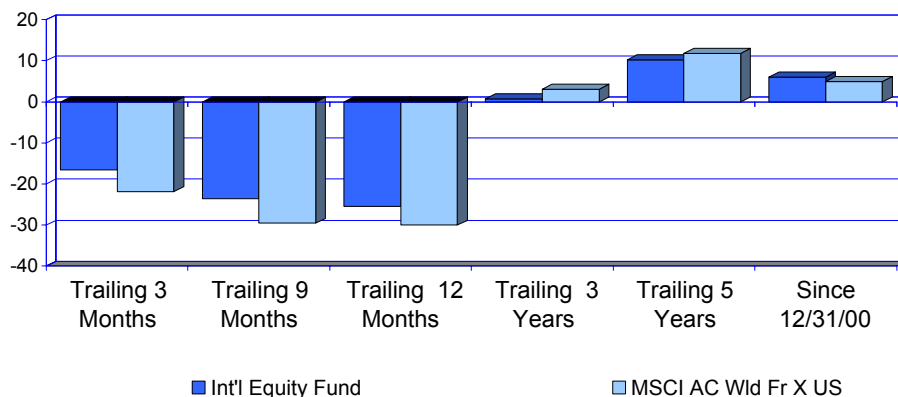

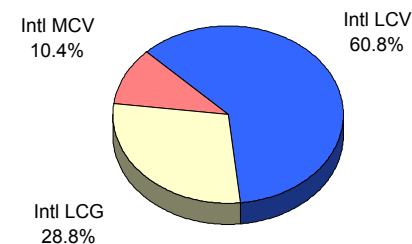

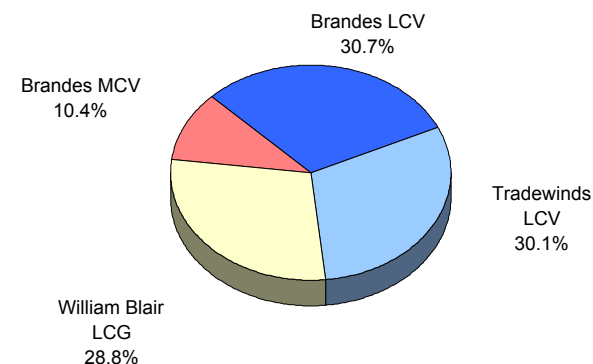

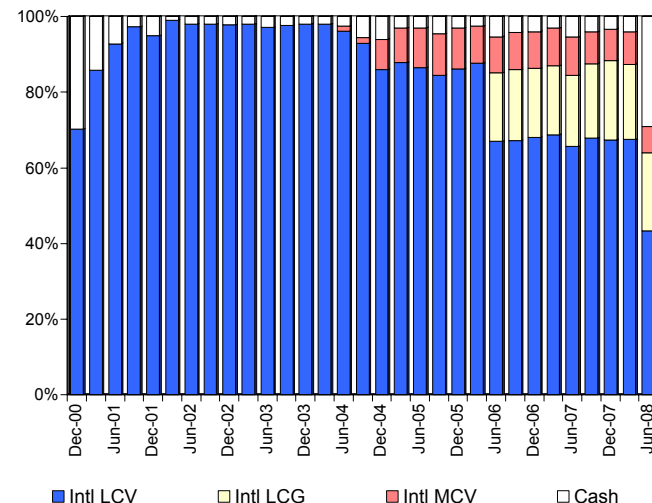
